The quality and standards of the early years provision

The provision does not meet requirements

- In the absence of the manager, there is no named deputy who is qualified and capable to take charge and contingency arragements do not ensure requirements to have suitable people are always met.
- The arrangements do not ensure that there is always a member of staff with a current paediatric first-aid certificate or suitable childcare qualifications present at all times. This is also a breach of the Childcare Register.
- Information on staff Disclosure and Barring Service checks and the staff vetting process is not available for inspection. Therefore, the suitability of staff cannot be demonstrated and assured. This means that children's safety is compromised.
- Although drinking water is on site, children cannot always access this themselves and, therefore, their independence or ability to recognise and meets their own needs are not well supported.
- Staff have a suitable understanding of child protection and what to do if they have a concern in order to safeguar children.
- Children have access to a selection of appropriate games, equipment and activities to complement their learning.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children on roll when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children on roll, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

Inspection activities

- The inspector discussed with staff how they deliver the educational programmes for children.
- The inspector discussed concerns and general practice with a member of staff.
- The inspector viewed the premises, resources and areas used by children.
- The inspector looked at children's assessment records and photographs of children's activities and spoke to older children who were present.

Information about the setting

The Cookie Club was registered in 2013 on the Early Years Register and the compulsory and voluntary parts of the Childcare Register. It is situated in the dining hall of Wilshire Dacre Junior School, in Hitchin, Hertfordshire. The club serves four schools in the local area and is one of two settings owned and managed by a limited company. There are enclosed areas available for outdoor play. The club employs nine staff who work between the two settings. Two members of staff are currently studying for degree level qualifications, three members of staff hold level 3 qualifications, one staff member holds a level 2 qualification and three are unqualified. The club opens from 7.45am until 8.45am and from 3pm until 6pm during the school term. There are approximately twenty eight children on roll, two of which are in the early years age group. Children attend for a variety of sessions. At the time of inspection, there were no early years children present.

What the setting needs to do to improve further

To meet the requirements of the Early Years Foundation Stage the provider must:

- ensure the deployment of staff is reviewed so there are always suitably qualified staff present in order to meet the needs of children, with particular reference to contingency plans for when the manager cannot be present
- ensure that there is a named deputy who is qualified and capable to take charge when the manager is absent
- ensure that information of staff suitability, to include details of Disclosure and Barring Service checks, is available for inspection.

To further improve the quality of the early years provision the provider should:

 improve opportunities for children to develop their independence and manage some of their care needs themselves for example by enabling children to access drinks themselves.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages. It regulates and inspects childcare and children's social care, and inspects the Children and Family Court Advisory Support Service (Cafcass), schools, colleges, initial teacher training, work-based learning and skills training, adult and community learning, and education and training in prisons and other secure establishments.
