The quality and standards of the early years provision

The provision meets requirements

- The provider demonstrates, through discussion, a suitable knowledge of the safeguarding and welfare requirements of the Early Years Foundation Stage, as a result, she understands how to safeguard children.
- The provider demonstrates, through discussion, a suitable knowledge and understanding of the learning and development requirements of the Early Years Foundation Stage. She has systems in place to enable her to provide planned, purposeful play experiences that takes into account children's individual learning needs.
- The provider demonstrates that the club have devised appropriate behaviour management strategies so that children are supported to behaviour well while at the club.
- The provider demonstrates a sound understanding of how she would share information with parents. This means that she can work with parents to support the learning and care needs of the children.
- The environment is clean and suitably resourced with a range of toys and equipment to meet the needs of the different age groups of children. The provider shows an understanding of how to provide a nurturing environment to give the children a strong sense of belonging and promote their well-being. There are appropriate risk assessment procedures to ensure the children are safe in the club.
- The provider has suitable arrangements in place to enable the club to work collaboratively with schools, and other settings that children attend, to support the learning and care needs of the children.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle – the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children on roll when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children on roll, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

Information about the setting

Blackwell Busy Bees Out of School Club was registered in 2009. It operates within the Blackwell Primary School in the village of Blackwell, near Alfreton, Derbyshire. The setting is registered on the Early Years Register and the compulsory and voluntary part of the Childcare Register. The club is open Monday to Friday from 8am to 9am and 3.30pm to 5.30pm during term time. Children attend for a variety of sessions. The club employs five members of childcare staff, of whom three hold an appropriate early years qualification at level 3. At the time of the inspection, there were no children on roll in the early years age group.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages. It regulates and inspects childcare and children's social care, and inspects the Children and Family Court Advisory Support Service (Cafcass), schools, colleges, initial teacher training, work-based learning and skills training, adult and community learning, and education and training in prisons and other secure establishments.
