The quality and standards of the early years provision

The provision meets requirements

- The childminder demonstrates, through discussion, a suitable knowledge of safeguarding procedures and how to safeguard children.
- The childminder demonstrates a suitable knowledge and understanding of the learning and development requirements of the Early Years Foundation Stage.
- The childminder has a sound understanding of how she would provide planned, purposeful play experiences that take account of the individual learning needs of the children.
- The childminder holds a current paediatric first aid certificate. This means that she has an up-to-date knowledge of how she would deal with accidents. She is aware of the need to maintain records on accidents and injuries.
- The childminder demonstrates, through discussion, a sound knowledge of appropriate behaviour management strategies.
- The childminder shows how she would share information with parents. This means that she can work with parents to support the learning and care needs of the children.
- The environment is clean and suitably resourced with a range of toys and equipment to meet the needs of the different age groups of children.
- The childminder demonstrates how she would work together with schools to support the learning and care needs of the children.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle – the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children on roll when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children on roll, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

Inspection activities

- The inspector discussed with the childminder how she intends to deliver the educational programmes for children.
- The inspector looked at policies and documents that the childminder will use when caring for children.
- The inspector checked evidence of suitability and qualifications of the childminder, the childminder's self-evaluation form and improvement plan.

Information about the setting

The childminder was registered in 2009. She lives with her husband in the Chapeltown area of Sheffield. The whole of the ground floor and first floor bathroom is used for childminding purposes. There is an enclosed garden available for outside play activities and the childminder lives within walking distance of local parks, shops and schools. The childminder is registered on the Early Years Register and on the compulsory and voluntary part of the Childcare Register. She is able to take and collect children from local schools and pre-schools. The childminder operates all year round from 7.45am to 6pm, Monday to Friday, except bank holidays and family holidays. At the time of the inspection, there were no children on roll in the Early Years Foundation Stage.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages. It regulates and inspects childcare and children's social care, and inspects the Children and Family Court Advisory Support Service (Cafcass), schools, colleges, initial teacher training, work-based learning and skills training, adult and community learning, and education and training in prisons and other secure establishments.
