The quality and standards of the early years provision

The provision meets requirements

- The childminder has a satisfactory awareness of the learning and development requirements. She has previous experience of planning for individual children's needs and completing observational assessments.
- The childminder provides an appropriate range of resources and activities that meet the needs of children at different stages of their learning and development.
- The childminder develops strong partnerships with parents, which helps to ensure she consistently meets children's needs, and forms good relationships with them.
- The childminder effectively identifies and minimises risks in her home. Children are safeguarded because the childminder is suitably aware of her responsibilities to protect them from harm.
- The childminder has a suitable understanding of the importance of evaluating her practice to identify areas for improvement.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children on roll when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children on roll, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

Inspection activities

- The inspector had a tour of the childminder's home.
- The inspector held discussions with the childminder regarding how she intends to deliver the educational programmes for children.
- The inspector looked at policies and documents the provider will use when caring for children.
- The inspector discussed self-evaluation and plans for improvement with the childminder.
- The inspector sampled relevant documentation, including policies and procedures, and the childminder's suitability.

Information about the setting

The childminder was registered in 1986 and is on the Early Years Register and the compulsory and voluntary parts of the Childcare Register. She lives in Coventry with her husband. The whole ground floor and upstairs bathroom are used for childminding. There is a fully enclosed garden for outside play. There were no children on roll in the early years age range at the time of the inspection. The childminder attends a toddler group and visits the park on a regular basis. She takes children to and collects them from the local schools and pre-schools. The childminder operates term time from 8am until 5pm Monday to Friday.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.
