The quality and standards of the early years provision

The provision meets requirements

- The early years provision meets the needs of the range of children who attend because the childminder understands how children learn and develop through play. She has a wide range of toys and resources to support learning and development in all areas.
- There are appropriate systems in place to promote the learning, development and assessment requirements of the Early Years Foundation Stage. This includes establishing what children can do on entry, completing observations and assessments to inform children's activity plans and tracking their progress towards the early learning goals.
- The contribution of the early years provision to children's well-being is good. The childminder has a sound knowledge and understanding to support children to learn about keeping themselves safe and healthy.
- The leadership and management of the early years provision are adequate. There are appropriate systems in place for the childminder to monitor, evaluate and prioritise aspects of the provision to be developed.
- The childminder is aware of the need to work in partnership with parents and others who are involved in the care and learning of the children, to ensure that children receive relevant support and continuity in their learning and development.
- The actions and recommendations raised at the last inspection have been addressed. The childminder has completed a paediatric first aid course, valid insurance is in place and she has attended a wealth of training and accessed support to further develop her knowledge of the Early Years Foundation Stage including the progress check completed between the age of two and three years.
- The childminder demonstrates that she understands her role and responsibility with regard to safeguarding children. All policies, procedures and risk assessments are in place and are shared with parents.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children on roll when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children on roll, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

Inspection activities

- The inspector discussed with the childminder how she intends to deliver the educational programmes for children.
- The inspector looked at policies, procedures and documents the childminder will use when caring for children.
- The inspector discussed with the childminder the self-evaluation form and her future plans to develop the provision in the children's best interests.
- The inspector checked evidence of the childminder's qualifications and of the suitability of all adults in the home.

Information about the setting

The childminder was registered in 1995 and is on the Early Years Register and the compulsory and voluntary parts of the Childcare Register. She lives with her husband and adult daughter in a house in Bedlington, Northumberland. The whole of the ground floor, bathroom on the first floor and the rear garden are used for childminding. The childminder attends a toddler group and activities at the local children's centre. She visits the shops and park on a regular basis. She collects children from the local schools and pre-schools. There are currently three children on roll, one is in the early years age group and attends for a variety of sessions. There were no children in the early years age group present on the day of the inspection. She operates all year round from 7am to 6pm, Monday to Friday, except bank holidays and family holidays. She is a member of Professional Association for Childcare and Early Years.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages. It regulates and inspects childcare and children's social care, and inspects the Children and Family Court Advisory Support Service (Cafcass), schools, colleges, initial teacher training, work-based learning and skills training, adult and community learning, and education and training in prisons and other secure establishments.
