The quality and standards of the early years provision

The provision meets requirements

- Following a notification to Ofsted, concerns were raised about the provider's failure to notify Ofsted of a significant event. At a visit, it was found that the provider had not notified Ofsted of an incident relating to her own family members as she did not realise this was a requirement. Now she is aware, she will infrom Ofsted on any future occasion.
- The childminder has sufficient knowledge of the learning and development requirements. She is aware of the need to plan for children's individual learning by finding out about their likes and interests. She understands the importance of completing observations to assess children's progress.
- The childminder extends a friendly and warm welcome. The areas to be used for the care of the children are bright and accessible to all children. Equipment and resources provided are suitable for a range of ages and are easily access to the children. She acknowledges the importance of working with parents and providers, to promote continuity of care in children's learning and development.
- The childminder understands how to manage children's behaviour by providing clear and consistent boundaries. This ensures that children know what is expected of them. The childminder fully understands that behaviour strategies must not be used that could adversely affect a child's well-being.
- The childminder understands her responsibility to safeguard children and the procedure to follow in the event of her having concerns about a child's welfare. She understands the need to ensure children are well supervised by providing a safe and secure environment.

Information about this inspection

Inspections of registered early years provision are:

There were no children on roll when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children on roll, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

- The inspector had a tour of the premises and viewed all areas that are used when caring for children.
- The inspector discussed with the childminder how she intends to deliver the educational programmes for children.
- The inspector looked at policies, procedures and documents the childminder will use when caring for children.
- The inspector checked evidence of suitability and qualifications of the childminder
- and her household members and talked with the childminder about her selfevaluation and improvement plans.

Information about the setting

The childminder was registered in 2012 and is on the Early Years Register and compulsory and voluntary parts of the Childcare Register. She lives with her children aged 17, 15, and nine years in Coventry, Warwickshire. The whole of the ground floor is used for childminding. There is a garden available for outside play. There are currently no children attending who are within the Early Years Foundation Stage, age group. The childminder collects children from the local school and pre-school. The childminder operates all year round, 8am to 6pm Monday to Friday, except bank holidays and family holidays. The childminder supports children who speak English as an additional language.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.
