## Monitoring for provision judged as inadequate

An Ofsted inspector, Laura Hoyland, monitored your provision on 02/06/2014 following your inspection where the provision was judged to be inadequate.

## **Outcome of monitoring**

As a result of our inspection on 04/03/2014, we sent you a notice to improve. The actions you were set are included at the end of this letter.

During the monitoring visit the inspector discussed with you the steps you have taken to address the actions raised in the notice to improve. She held discussions with you and your assistant. The inspector had a tour of the premises, discussed the areas regarding development and looked at planning documents. She also observed your interaction with children during play. You explained that you have had some support from the local authority.

The inspector found that you have a clear plan to move forward in order to address all actions raised at the last inspection. For example, each child has a comprehensive development file with baseline assessments, regular observations and tracking of their individual progress. Furthermore, you have devised a system to ensure all areas of learning are covered in depth by providing activities to challenge children of all ages and stages of development.

The inspector found that you have updated your knowledge and understanding of the learning and development requirements of the Early Years Foundation Stage. You are aware of the prime and specific areas of learning and how to incorporate these into the everyday routines and practice. Enjoyable activities are planned for children across all areas of learning and you understand the importance of reflecting on how children learn through different experiences and activities. You plan interesting activities that are flexible depending on children's interests and ensure all children are motivated to learn.

It is evident that you liaise closely with parents regarding their children's learning. For example, holding daily conversations with parents. These included discussing what children have enjoyed taking part in and future plans for their learning. Daily diaries are in place and enable a two-way flow of information between home and Our Reference 401420

your setting. Furthermore, you regularly observe and assess children using a computer program, which updates parents following any new information that is added. Also, termly parent meetings mean that children's learning and development is supported continuously between home and your setting.

Having considered all the evidence, the inspector is of the opinion that the childminder has taken prompt and effective action to address the points for improvement.

## **Next steps**

The next step will be a full inspection.
