The quality and standards of the early years provision

The provision meets requirements

- The childminder has an appropriate early years qualification and experience of planning a programme of activities to support the learning and development of individual children. She describes how she observes and assesses children and uses the information gathered to plan for the next steps in children's learning.
- The childminding provision is a warm and welcoming environment for children to access. Resources are of good quality and the childminder understands how to assess and minimise risk effectively.
- The childminder has a sound knowledge and understanding of safeguarding policies and practice, to ensure children are effectively safeguarded.
- Through discussion, the childminder demonstrates a commitment to building links with parents, other professionals and other early years settings to support children's learning and development and ensure their care needs are met.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children on roll when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children on roll, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

Inspection activities

- The inspector had a tour of the childminder's home.
- The inspector held discussions with the childminder and her assistant regarding how they intend to deliver the educational programmes for children.
- The inspector checked evidence of suitability of all members of the household and the childminder's qualifications.
- The inspector looked at policies and documents the childminder will use when caring for children and discussed self-evaluation and her plans for future improvement.

Information about the setting

The childminder was registered in 2007 and she is registered on the Early Years Register and on both the compulsory and voluntary parts of the Childcare Register. She lives in Coventry with her husband and 10-year-old child. The childminder's husband works alongside her as an assistant. The whole of the ground floor, back bedroom and upstairs bathroom are used for childminding. The childminder is registered to provide overnight care. There is an enclosed garden for outdoor play. There were no children on roll at the time of the inspection. The childminder attends a toddler group and visits the park on a regular basis. She takes children to and collects them from the local schools and preschools. The childminder operates all year round from 8am to 6pm, Monday to Friday, except bank holidays and family holidays. She has an early years qualification at level 3.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.
