The quality and standards of the early years provision

The provision meets requirements

- The childminder demonstrates that she is able to meet the learning and development requirements of the Early Years Foundation Stage. She has a secure understanding of the ways in which young children learn. Consequently, she describes how she intends to provide suitable resources and planned purposeful experiences to help children to make progress.
- The childminder has a range of supporting documentation to assist her in making observations and assessments of children's starting points. She has a range of formal assessment methods ready to enable her to complete the progress check for children between the ages of two and three years.
- The childminder has appropriate methods to support children to develop healthy lifestyles. These include promoting healthy eating, regular outdoor experiences and good hygiene practices. She holds a valid first-aid certificate and relevant documentation, such as medication and accident records, are in place.
- The childminder demonstrates a secure understanding of the typical signs and symptoms of abuse. She demonstrates through discussion her ability to identify concerns and respond appropriately, following the guidance set by the Local Safeguarding Children Board.
- The childminder evaluates her provision and demonstrates her commitment to improving practice as she has successfully met all recommendations set at the last inspection. She has a positive attitude to working in partnership with parents and other professionals as required.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children on roll when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children on roll, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

Inspection activities

- The inspector looked at the areas intended to be used for childminding, including the outdoor area and held discussions in relation to health and safety.
 - The inspector discussed with the childminder how she intends to deliver the
- safeguarding and welfare requirements and the learning and development requirements.
 - The inspector looked at and discussed a sample of policies and procedures,
- including the safeguarding policy and risk assessment procedures. Evidence to confirm the suitability of the childminder was also checked.
 - The inspector discussed the process of self-evaluation, including establishing
- whether previous recommendations had been addressed appropriately and plans for further improvements.

Information about the setting

The childminder was registered in 2008 on the Early Years Register and the compulsory and voluntary parts of the Childcare Register. She lives with her three children aged 11 months, eight years and 11 years in a house in Warton, an area of Preston. The whole of the ground floor, which includes a downstairs bathroom and rear garden, are used for childminding. The childminder has two cats as family pets. She collects children from the local schools and attends parent and toddler groups on a regular basis. The childminder operates all year round from 8am to 5.30pm, Monday to Friday, except bank holidays and family holidays. She is a member of the Professional Association for Childcare and Early Years. At the time that the inspection was carried out, there were no children on roll.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.
