The quality and standards of the early years provision

The provision does not meet requirements

- The provider demonstrates that she has a clear understanding of the learning and development requirements. She is clear about how to carry out assessments in order to monitor children's progress.
- The provider has considered how to plan for children's individual needs and incorporate children's interests. She recognises the importance of linking closely with the school and parents, to help her to support children's learning and development.
- Through discussion, the provider demonstrates that she is clear about safeguarding policies and procedures. She is aware of her role and responsibilities to provide children with a safe and secure environment. She has policies and procedures in place that are made available to parents on the club website.
- The provider has considered ways to improve the provision to benefit children. She recognises that working together with the staff to review the day's activities enables all staff to reflect on what worked well. This will enable them to continually develop the play and learning experiences offered to children.
- The provider has not taken the appropriate action to notify Ofsted of the change of manager, which is a breach of the legal requirements.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle – the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children on roll when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children on roll, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

- The inspector discussed with the provider and staff the play activities and learning experiences they provide for children.
- The inspector looked at policies and documents the provider has in place and how she uses these when caring for children.
- The inspector discussed with the provider the systems used to evaluate the provision to help her with ongoing development.

Information about the setting

The Funtastic Club registered in 2013. It is privately owned. The club is situated within Burton Primary School, in Christchurch, Dorset. The club have access to three classrooms, a quiet room and the school hall. Toilet facilities are easily accessible off the corridors. All children have access to the school play ground, playing field and a enclosed garden area. The club is open Monday to Friday from 7.45am to 9am and 3pm to 6pm term time only. The club is registered on the Early Years Register and both the compulsory and voluntary parts of the Childcare Register. There are currently 26 children on roll, which includes one early years child. No early years children were present at the time of the inspection. The club supports children with special education needs and/or disabilities. There are three staff who work with the children, including the owner. All staff who work directly with the children hold early years qualifications.

What the setting needs to do to improve further

To meet the requirements of the Early Years Foundation Stage the provider must:

- ensure that systems are put in place to notify Ofsted of any changes to the person who is managing the early years provision.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages. It regulates and inspects childcare and children's social care, and inspects the Children and Family Court Advisory Support Service (Cafcass), schools, colleges, initial teacher training, work-based learning and skills training, adult and community learning, and education and training in prisons and other secure establishments.
