The quality and standards of the early years provision

The provision meets requirements

- The childminder has a good knowledge and understanding of the Early Years Foundation Stage, child development and all areas of learning, including the progress check for children, which is completed between the ages of two and three years. She has a good selection of resources for a wide age range that children can independently access.
- The childminder has a good understanding of how to promote children's well-being and she provides a safe, healthy and hygienic home for children. This is enhanced as she maintains all required and additional records and documents to underpin children's safety and welfare.
- The childminder understands her role and responsibility in regard to safeguarding children. All policies and procedures are in place and shared with parents. She has a good awareness of her legal requirements. The childminder has a good awareness of continuous development in her own professionalism in order to maintain a good and safe environment for children in her care to progress.
- The childminder has a good understanding of the importance of working with parents and other professionals in order to ensure a good continuous monitoring of children's progress in their learning.
- The childminder keeps children safe. Following a recent visit by Ofsted, which identified that the rear garden was not secure, the childminder has made this area secure by erecting a new boundary fence.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children on roll when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children on roll, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

Inspection activities

- The inspector looked at the resources on offer to children.
 - The inspector looked at the childminder's documentation, including suitability checks
- of all members of the household over 16 years, risk assessments and policies and procedures.
- The inspector toured the areas of the home used by the childminder for childminding, including kitchen, lounge, upstairs bathroom and rear garden.
- The inspector discussed with the childminder her suitability and how she implements a safe home for children.

Information about the setting

The childminder was registered in 2011 and is on the Early Years Register and the compulsory and voluntary parts of the Childcare Register. She lives with her husband and children aged 11 years old years in a house in Halifax, West Yorkshire. The whole of the ground floor, upstairs bathroom and rear garden are used for childminding. The family has a dog as a pet. The childminder attends a toddler group and activities at the local children's centre. She visits the shops and park on a regular basis and collects children from the local schools and pre-schools. There are currently six children on roll, none of whom are in the early years age group and attend for a variety of sessions. She operates all year round from 7am to 6pm, Monday to Friday, except bank holidays and family holidays. The childminder is a member of the Professional Association for Childcare and Early Years. There are currently no children on roll.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.
