The quality and standards of the early years provision

The provision meets requirements

- The staff demonstrate, through discussion, their sound understanding of how to nurture and support children's emotional well-being so that they feel happy, settled and secure. Staff are knowledgeable in how they will support children as they begin at the setting and as they attend after school so that their transitions are seamless and wellsupported.
- The staff are experienced and well-qualified. Through discussion, they demonstrate their secure understanding of the learning and development requirements. They are knowledgeable in how they will use the detailed observations and assessments to clearly record the progress that children are making, and to identify the next steps in their learning.
- The staff have a secure understanding of how children learn. They discuss the importance of planning a range of challenging experiences for children to engage in that supports them in their all-round development.
- The staff have in-depth knowledge of how to safeguard children. They have a firm understanding of the procedures that they would need to take if they have any concerns about a child in their care. Effective systems are in place to check the equipment and resources on a daily basis to ensure that they are protected from harm.
- The staff confidently discuss how they will involve parents in their children's learning using a range of strategies. They value the contributions from parents and have a clear understanding of how they will complement children's learning within the setting. This will ensure that they benefit from continuity in their learning and development.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children on roll when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children on roll, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

Inspection activities

- The inspector had a tour of all of the areas used by the club.
- The inspector observed the environment and the range of resources that will be made available to the children within the club.
- The inspector held discussions with the manager and her assistant during the course of the inspection.

The inspector looked at a range of supporting documentation relating to the setting. These included observation and assessment documents, the policies and

procedures, staff suitability checks, information for parents and a record of staff training.

Information about the setting

St Michaels After School Club was registered in 2000 and is on the Early Years Register and the compulsory and voluntary parts of the Childcare Register. It is situated in St Michaels Church of England Primary School in Dalston, Cumbria and is managed by a committee. Children have access to a designated classroom, the main hall and toilet facilities within the school. There is a secure outdoor area for children to access. The club employs three members of childcare staff. Of these, two hold appropriate early years qualifications at level three. The manager holds Qualified Teacher Status. The club opens Monday to Friday from 3.30pm until 5.30pm during term time. Children attend for a variety of sessions. There are currently 56 children on roll who are aged between six years and 11 years. At the time of the inspection, there were no children on roll in the early years age range.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages. It regulates and inspects childcare and children's social care, and inspects the Children and Family Court Advisory Support Service (Cafcass), schools, colleges, initial teacher training, work-based learning and skills training, adult and community learning, and education and training in prisons and other secure establishments.
