The provision meets requirements

- Staff demonstrate a sound understanding of how to effectively meet the needs of children.
- They understand how children learn and how to observe and plan for their individual needs. Through discussion and in looking at the range of equipment, the provider demonstrates that children will experience a broad and balanced programme of learning.
- Leadership and management are effective. Staff understand their roles and are able to demonstrate that they meet the welfare requirements, including safeguarding.
- The required documentation is in place to help ensure children's safety and welfare. Staff have some good ideas of how to drive improvement through various self-evaluation methods and by working with external services.
- Through discussion, staff understand how to promote children's well-being. Staff understand the importance, and have some good ideas, of how to work in partnership with parents effectively.
- Staff have good knowledge and understanding of child protection issues and how to deal with any concerns. Children are safe and secure as the premises are suitable. Staff understand their role in regularly checking the environment to minimise the risks of accidents.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children on roll when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children on roll, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Information about the setting

Manor Oak Early Years was registered in 2013. It is situated in the grounds of Manor Oak Primary School. It operates from 12.05pm to 3.05pm, five days a week, school term time only. Children have access to a large room with toilet and wash facilities. There is an outdoor play area which is shared with children from the adjacent nursery room. Manor Oak Early Years is registered on the Early Years Register only. The manager of the provision has a level three qualification and other staff have level two and three childcare qualifications.

There were no children on roll at the time of inspection.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages. It regulates and inspects childcare and children's social care, and inspects the Children and Family Court Advisory Support Service (Cafcass), schools, colleges, initial teacher training, work-based learning and skills training, adult and community learning, and education and training in prisons and other secure establishments.
