The quality and standards of the early years provision

The provision meets requirements

- The provider and manager demonstrate, through discussion, a very good knowledge of the knowledge of the safeguarding and welfare requirements of the Early Years Foundation Stage. Staff understand about child protection and how to safeguard children to assure children's safety.
- The provider and manager demonstrate, through discussion, a very good knowledge and understanding of the learning and development requirements of the Early Years Foundation Stage. They have suitable procedures in place that enable staff to plan purposeful play experiences, which take into account children's individual learning needs.
- The provider has suitable arrangements in place to work collaboratively with schools and other settings that children attend, to support their learning and care needs.
- The provider and manager demonstrate that the club have devised appropriate behaviour management strategies in order to support children to behave well while at the club.
- The provider and manager show a good understanding of how to provide a nurturing environment to give the children a strong sense of belonging and promote their well-being. There are appropriate risk assessment procedures to ensure the children are safe in the club.
- The provider and manager show that they have sound procedures in place to work in partnership with parents in order to support children effectively with their learning and care needs.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children on roll when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children on roll, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

- The inspector checked evidence of safeguarding practices, staff recruitment and their ongoing professional development.

- The inspector discussed with the provider and manager how they deliver the educational programmes for children.

Information about the setting

Eureka Before and After School Club registered in 2008 on the Early Years Register and the compulsory and voluntary parts of the Childcare Register. It operates from rooms within Stretton Church of England Primary School, Coventry. It is run by a voluntary management committee and is one of two settings. Children have access to an enclosed, outdoor play area and use of the hall, sunshine room, library area and two classrooms. The club is open Monday to Friday from 3.15pm to 5.30pm term time only. The club serves the local and surrounding schools and children attend for a variety of sessions. There are currently 32 children on roll. It supports children with special educational needs and/or disabilities and those who speak English as an additional language. There are five members of staff, including the manager, who work directly with the children. Of these, two hold a National Vocational Qualification (NVQ) at level 5 in early years, two hold an NVQ at level 3 and one holds an NVQ at level 2. At the time of the inspection, there were no children present in the early years age group.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages.
