The quality and standards of the early years provision

The provision meets requirements

- All staff understand their roles and responsibilities in regard to safeguarding children. This is further supported by written policies and procedures, which include details of what to do should they have any concerns regarding a child in their care. As a result, children are fully safeguarded.
- The provider is aware of the need to work in partnership with parents and other professionals, such as teachers within the school. This helps to ensure children receive relevant support and continuity in their learning and development.
- The provider and staff have a sound knowledge and understanding of the Early Years Foundation Stage. A clear strategy is in place to identify strengths and areas for improvement as they consistently develop their practice further.
- Risk assessments are well-embedded into practice. As a result, premises are safe and secure and clear safety precautions in place to ensure that children are consistently protected from hazards.
- Children are provided with an interesting and motivating learning environment both inside and outside. For example, resources are accessible to help support children in making decisions in their play.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate

There were no children on roll when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children on roll, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

- Through discussion and observation of documentation the inspector checked that the provider was meeting the requirements of the Early Years Foundation Stage.
- The inspector spoke to the provider about her strategies to manage children's individual learning.
- The inspector spoke to the provider about her intentions for continuous improvement and self-reflection.
- The inspector looked at a sample of policies and procedures, which included safeguarding and complaints, planning records, risk assessment and a range of

- The inspector checked evidence of suitability and qualifications of the staff.
- The inspector spoke to parents for their views and comments on the service provided.

Information about the setting

Little Angels of Baschurch was registered in 2013 and is on the Early Years Register and the compulsory and voluntary parts of the Childcare Register. The provision is situated within Bashchurch Primary School, Shropshire. At the time of the inspection there were no children present in the early years age range. The provision serves the local area and is accessible to all children. There is an enclosed area available for outdoor play. The provision employs two members of childcare staff. Of these, one holds Qualified Teacher Status. Sessions are from 8am until 8.40am and 3pm until 6pm Monday to Friday term time only. There are currently 43 children on roll in the older years age range. Children attend for a variety of sessions.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages.
