The quality and standards of the early years provision

The provision meets requirements

- The childminder demonstrates that she is able to meet the learning and development requirements of the Statutory framework for the Early Years Foundation Stage. She has a secure understanding of the ways in which young children learn and describes how she intends to provide suitable resources and activities to support children to make progress.
- The childminder understands how to promote children's well-being. She discusses the importance of providing children with a healthy diet and ensuring they have opportunities to experience fresh air and exercise. She understands how to manage children's behaviour in a positive way.
- The childminder demonstrates through discussion that she is aware of the importance of exchanging information with parents, carers and other providers. She understands this is important to promote continuity of care and learning for each child and to help them to feel settled and secure in their surroundings.
- The childminder holds public liability insurance and a current paediatric first-aid certificate.
- The childminder has sufficient knowledge of child protection procedures approved by the Local Safeguarding Children Board. She fully understands her responsibility to protect the welfare of the child.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children on roll when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children on roll, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the compulsory part of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

Inspection activities

- The inspector looked at the areas of the home, both inside and outside, that would be used for childminding and the resources available.
- The inspector discussed with the childminder how she intends to deliver the
- safeguarding and welfare requirements and the learning and development requirements.
 - The inspector looked at and discussed a sample of policies, procedures and systems
- for recording information that the childminder will be using when caring for children in the early years age range.
- The inspector checked evidence of the suitability of the adults in the household and discussed how she evaluates her provision and plans further improvements.

Information about the setting

The childminder was registered in 1995 and is on the Early Years Register and the compulsory part of the Childcare Register. She lives with her three adult children in a detached house in Ross-on-Wye. The whole ground floor of the premises is used for childminding, this includes access to bathroom facilities. First floor rooms are not used. There is an enclosed garden for outdoor play. The family have three cats and some fish as pets. The childminder is able to take and collect children from local schools and preschools. There were no children on roll at the time of the inspection.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.
