The quality and standards of the early years provision

The provision meets requirements

- The nominated person fully understands her responsibility to ensure that the setting meets the safeguarding and welfare and learning and development requirements of the Early Years Foundation Stage.
- Recruitment, supervision and training for staff has a strong focus on safeguarding and child protection. All required documentation is in place, including written polices, to ensure the safe and efficient management of the setting when operating.
- The nominated person has high aspirations for the setting and implements thorough procedures for monitoring, coaching and supporting childcare staff. Good practice is disseminated between the associated provisions to ensure children receive high quality care and teaching.
- There is a stimulating well-resourced environment which is safe, secure and well maintained in order to promote children's learning and protect their welfare.
- The nominated person describes how she would support children's emotional well-being through implementing a well-planned key-person system. This is to ensure that attachments are formed and children's care is tailored to meet their individual needs.
- The nominated person recognises that good partnerships with parents and external agencies are essential in order to meet children's individual needs and receive the support they need. She is able to speak confidently about how she will develop these when childcare resumes.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children on roll when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children on roll, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

Inspection activities

■ The inspector had a tour of the premises and viewed all areas that are used when caring for children.

The inspector held discussions with the nominated person to check her knowledge and understanding of the safeguarding and welfare requirements and the learning

- and development requirements of the Statutory framework of the Early Years Foundation Stage.
- Evidence of the suitability of the staff was checked.
- The inspector discussed with the nominated person their procedures for selfevaluation and development of the provision.

Information about the setting

The Downhill Centre was registered in December 2000 and is a committee run facility. It is registered on the Early Years Register and the compulsory and voluntary parts of the Childcare Register. It operates from the former Downhill Primary School site in Sunderland. The setting has a large childcare area, toilets, kitchen, staff facilities and an outdoor play area. The group serves the local and surrounding communities. The setting is open Monday to Friday, from 8am to 6pm, all year round. The registered provider employs a core team of 24 staff who are available to work across their settings. All hold early years qualifications at level 3 and above. At the time of the inspection, there were no early years children on roll.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages. It regulates and inspects childcare and children's social care, and inspects the Children and Family Court Advisory Support Service (Cafcass), schools, colleges, initial teacher training, work-based learning and skills training, adult and community learning, and education and training in prisons and other secure establishments.
