## **The quality and standards of the early years provision**

### **The provision does not meet requirements**

- The childminder has failed to obtain public liability insurance. This was also a concern at the childminder's last inspection. This is a breach of welfare requirements and shows that the childminder has a poor capacity for continuous improvement.
- The childminder understands the possible indicators that a child may be at risk of harm and knows what to do if she has concerns. This helps to safeguard children.
- The childminder demonstrates through discussion how she supports children to learn right from wrong through behaviour management. This helps to promote children's well-being.
- The childminder demonstrates through discussion how she assesses children's progress and individual needs in order to meet their learning and development requirements. She has a range of resources to support their learning and understands how to plan activities that will help them to make progress in all areas.

## Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle – the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children on roll when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children on roll, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

## Inspection activities

- The inspector spoke with the childminder regarding her practice and care of the children.
- The inspector looked through a sample of documents including registers.

### Information about the setting

The childminder registered in 2007. She lives with her partner and their daughter. They live in a ground floor flat situated within the London Borough of Wandsworth. The lounge and the main bedroom are used for childminding. Children have access to an enclosed garden. The family has two dogs.

The childminder is registered on the Early Years Register and the compulsory and voluntary parts of the Childcare Register. At the time of this inspection, there were no children on roll in the early years age group. The childminder has a childcare qualification at level 3.

### What the setting needs to do to improve further

We will issue a Welfare Requirements Notice requiring the provider to: obtain public liability insurance.

## Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages. It regulates and inspects childcare and children's social care, and inspects the Children and Family Court Advisory Support Service (Cafcass), schools, colleges, initial teacher training, work-based learning and skills training, adult and community learning, and education and training in prisons and other secure establishments.
