The quality and standards of the early years provision

The provision does not meet requirements

- Staff do not follow the policies and procedures for safeguarding. Some staff do not fully understand the procedures to follow should they have any concerns about children in their care and staff do not follow the procedures for keeping their mobile phones in the office. Consequently, children's safety and welfare cannot be assured.
- The provider does not ensure that all documentation related to staff qualifications, recruitment and training is available for inspection. Therefore, staff suitability cannot be fully assured.
- Staff are aware of the need to provide a range of activities which take into account children's interests and needs.
- Staff explain how they promote children's well-being by providing generally nutritious snacks and drinks and offering opportunities for physical exercise.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children on roll when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children on roll, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

Inspection activities

- The inspector had a tour of the premises.
- The inspector observed children's activities.
- The inspector took account of the views of the parents.
- The inspector sampled the club's policies and discussed safeguarding procedures with the staff.
- The inspector met with the provider to discuss how they meet the Early Years Foundation stage requirements.

Information about the setting

Happy Days Club is one of five and is privately owned. It opened in 2006 and changed ownership in 2013. The club operates from a community hall in Willesden in the London Borough of Brent. The club is open term time only from 3.45pm to 6pm. Children have access to four separate areas, one of which is on the first floor. A large hall is available for sports activities and children can use information technology resources on the first floor. There is space for children to hang their coats and belongings. There is a small enclosed outdoor area to the side of the hall. The club is accessed by a separate entrance. The setting is registered on the Early Years Register and the compulsory and voluntary part of the Childcare Register. There are currently no children on roll in the early years age range.

What the setting needs to do to improve further

To meet the requirements of the Early Years Foundation Stage the provider must:

- ensure that safeguarding policies and procedures are implemented effectively and followed consistently with regards to keeping personal mobile phones and belongings away from the children and knowing how to refer concerns to outside agencies
- ensure documentation is accessible and available for inspection, particularly information relating to staff recruitment, qualifications and training.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.
