The quality and standards of the early years provision

The provision meets requirements

- The provider has a sound knowledge and understanding of the learning and development requirements of the Early Years Foundation Stage. Through discussion, she demonstrates how she provides appropriate learning opportunities, to meet the children's individual needs.
- The provider appropriately demonstrates how she promotes children's safety and welfare. For example, she ensures that risk assessments of the premises are carried out daily and that entry to the building is secure.
- The provider gains information from parents and teachers in order to support the children's individual care and learning needs throughout their time at the club.
- The provider understands how to promote children's well-being. She demonstrates that she provides children with a choice of healthy snacks and daily opportunities for fresh air and exercise. She also understands how to positively manage children's behaviour.
- The provider and her staff have sufficient knowledge of child protection procedures and their responsibility to protect the welfare of the children in their care.
- The provider has met the actions and recommendations set at the last inspection. This has resulted in positive outcomes with regard to staff recruitment and vetting, staff supervision and training, policy review and development, healthy snacks and information sharing with parents. This demonstrates the provider's capacity to improve and to further develop the provision.
- Parents of older children who attend the club report that they are pleased with the service provided and the information shared with them by club staff. They state that their children are happy, enjoying the range of activities available and the freedom to make independent choices.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children on roll when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children on roll, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

Inspection activities

- The inspector and provider toured the areas of the premises where childcare is to be provided.
- The inspector and the provider discussed and looked at toys, books, resources and equipment that she intends to use.
- The inspector discussed with the provider how she intends to deliver the educational programme for children.
- The inspector looked at policies and documents the provider will use when caring for children and discussed self-evaluation and improvement plans.
- The inspector checked evidence of suitability and training of the provider and suitability of other childcare staff.
- The inspector took account of the views of parents and carers of older children attending the setting who were spoken to on the day.

Information about the setting

The 4-14 Out of School Club was registered in 2002 and is on the Early Years Register and the compulsory and voluntary parts of the Childcare Register. It is situated in the Youth and Community Centre in Stone, Staffordshire and is privately owned and managed. The club serves the local area and is accessible to all children. There is an enclosed area available for outdoor play. The out of school club employs four members of childcare staff. Of these, two hold appropriate early years qualifications at level 3. The club opens, Monday to Friday, during term time. Sessions are from 7.30am until 9.15am and 3.20pm until 5.45pm. Children attend for a variety of sessions. In addition, a holiday club is provided during school holidays from 7.30am until 5.45pm by request from parents. There are currently 30 children attending, one of whom is within the early years age group. At the time of the inspection, there were no early years age range children present.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages.
