An Ofsted inspector, Elizabeth Coffey, monitored your provision on 08/07/2014 following your inspection where the provision was judged to be not met (enforcement).

Outcome of monitoring

As a result of our inspection on 25/02/2014, we sent you a welfare requirements notice. If you were set actions at the inspection, or as a result of our subsequent monitoring or investigations, these are included at the end of this letter unless we have already verified that they have been completed.

The welfare requirements notice required you to comply with the Statutory Framework for the Early Years Foundation Stage under the following requirements: Premises-obtain public liability insurance.

You were also sent a notice to improve. The actions you were set are included at the end of this letter.

During the monitoring visit on 8 July 2014 the inspector discussed with you the steps you had taken to comply with welfare requirements notice and to the address the actions raised in the notice to improve. You provided proof of public liability insurance cover and the inspector noted that this was valid to 9 March 2015. You admitted that you had failed to maintain required insurance cover in the past and assured the inspector that this cover would be maintained in line with the requirements of your registration as a childminder.

You had completed safeguarding training with the local authority and were able to demonstrate a sound knowledge and understanding of safeguarding matters. You had devised and implemented a safeguarding policy that included the action to take in the event of an allegation being made against yourself or other person associated with your setting.

Having considered all the evidence the inspector is of the opinion that at this time you have taken prompt and effective action to address the points for improvement.





Having considered all the evidence, the inspector is of the opinion that the childminder has taken prompt and effective action to address the points for improvement.
