The quality and standards of the early years provision

The provision meets requirements

- The childminder demonstrates, through discussion, a sound understanding of how to nurture and support children's emotional well-being so that they feel happy, settled and secure.
- The childminder demonstrates a secure understanding of the learning and development requirements and how she will help children make good progress in relation to their starting points. She will involve parents to promote continuity in their child's learning.
- The childminder shows an in-depth knowledge of how to safeguard children. She has a firm understanding of her policies and the procedures to follow if she is concerned a child in her care is at risk. She implements effective systems to check the equipment, resources and the environment both indoors and outside to help ensure the children are protected from harm.
- The childminder demonstrates a sound understanding of how to promote children's good health by meeting their dietary requirements and developing their awareness of good hygiene practices.
- The childminder demonstrates a sound knowledge of how to manage children's behaviour in ways that are developmentally appropriate. For example, she will engage with children positively and involve them in agreeing rules and boundaries.
- The childminder shows she has a positive attitude to continually improving her practice and to make on-going improvements.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle – the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children on roll when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children on roll, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

Inspection activities

- The inspector had a tour of all of the areas of the home used for childminding.
- The inspector observed the environment and the range of resources that will be made available to the children.
- The inspector held discussions with the childminder during the course of the inspection.
- The inspector looked at a range of supporting documentation. This included observation and assessment documents, policies and procedures, a first aid certificate, a disclosure and barring service check, public liability insurance and training certificates.

She does not have a garden but takes children out daily to a variety of groups and to the park. There are currently no children on role. The childminder is registered on the Early Years Register and both the compulsory and voluntary parts of the Childcare Register.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages. It regulates and inspects childcare and children's social care, and inspects the Children and Family Court Advisory Support Service (Cafcass), schools, colleges, initial teacher training, work-based learning and skills training, adult and community learning, and education and training in prisons and other secure establishments.
