The quality and standards of the early years provision

The provision meets requirements

- The manager has a clear understanding of how to safeguard children. She and all the staff have received training in child protection, and follow the guidance of the Local Safeguarding Children's Board to help protect children.
- The manager implements a range of policies and procedures to ensure the safe management of the setting.
- The manager demonstrates a secure knowledge of the learning and developments requirements of the Early Years Foundation Stage and how to plan to meet individual children's needs.
- The manager has a good range of suitable resources to cater for the individual needs of the children who attend.
- The manager demonstrates through discussion how she promotes children's well-being through the procedures she has in place.
- The manager explained how regular evaluation of the quality of provision helps to identify how their continuous drive for improvement is maintained.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children on roll when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children on roll, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

Inspection activities

- The inspector held discussions with the manager and the operations director, and reviewed documentation relating to safeguarding and children's safety.
- The inspector viewed a sample of the setting's documentation and discussed the delivery of the educational programmes for children.
- The inspector viewed the setting's self-evaluation and discussed how this led to the improvement plan for future development.
- The inspector toured the premises and discussed with the manager how the resources would be organised to support children's learning.

Information about the setting

Tenacious Kidz Care registered in 1993, and re-registered in 2010 and 2014. The setting is managed by a board and operates from Bethel-London's Riverside Church in Dagenham, in the London Borough of Barking and Dagenham. The children have access to the main hall, an outdoor play area, and daily access to the neighbourhood park. The setting is open each weekday from 9.30am to 12.30pm during term time only. The setting provides care for children from two years to under five years. The setting provides funding for the provision of free early education to children aged two, three and four years. There are currently 33 children on roll. The setting also provide after school care each weekday from 3pm to 6pm during term time and a holiday play scheme each weekday from 8am to 6pm during school holidays. The setting is registered on the Early Years Register and the compulsory and voluntary parts of the Childcare Register. The setting employs eight staff, of whom most hold appropriate early years qualifications. The setting supports children with special educational needs and/or disabilities, and children who learn English as an additional language. The setting receives support from the local authority. There were no children present at the time of the inspection.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages. It regulates and inspects childcare and children's social care, and inspects the Children and Family Court Advisory Support Service (Cafcass), schools, colleges, initial teacher training, work-based learning and skills training, adult and community learning, and education and training in prisons and other secure establishments.
