The quality and standards of the early years provision

The provision meets requirements

- Leadership and management is strong and well established. Staff have a secure knowledge and understanding of child protection procedures, which results in them being well aware of their responsibilities to keep children safe.
- Through discussion and the documentation sampled, staff demonstrate a strong awareness of how to observe and assess children's progress and how to involve parents in their children's learning. They know how to plan activities to complement the experiences children receive in school and they explain how they will promote children's development through providing fun learning experiences.
- Staff explain how they manage children's behaviour. They confirm how they work closely with children to create an environment that is friendly and based on appropriate boundaries agreed by staff and children.
- The environment is spacious and will be set up to provide opportunities for children to learn and play together, both inside and outside. Plans are in place to support children's learning through providing resources that are matched to their ages and interests. Staff also explain how they plan to use activities to promote children's awareness of healthy lifestyles.
- The leadership team are passionate about driving improvement and there is a strong emphasis on developing quality at every level. The leadership team are highly qualified, which means that they can support the continuous professional development of staff. Well-documented improvement plans are in place to ensure that the requirements of the Early Years Foundation Stage can be met in all areas.

Information about this inspection

Inspections of registered early years provision are:

- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate

There were no children on roll when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children on roll, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Kaleidoscope Care Limited was registered in 2013 on the Early Years Register and the compulsory and voluntary parts of the Childcare Register. It operates from rooms within Kirkby La Thorpe Primary School, near Sleaford, Lincolnshire. The club serves the children of this school. There is an enclosed area available for outdoor play and the club has further use of the school's field, hall and computer room. The club opens Monday to Friday, term time only. Sessions are from 3:15pm until 6pm. Children attend for a variety of sessions. There are currently ten older children on roll. However there were no early years children on roll at the time of the inspection.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages.
