The quality and standards of the early years provision

The provision meets requirements

- The provider explained how she assessed children's starting points on entry to the setting. Staff discuss how they provide activities around children's interests so that children's needs are met and they continue to be motivated to learn.
- The provider understands the requirements to safeguard children and demonstrates how she will do this by following the guidance of the Local Safeguarding Children Board. This promotes children's safety and well-being.
- The provider explained how she has worked in close partnership with parents and other settings children attend to complement their learning and development at the club.
- The provider gathers the views of parents and other professionals about the provision and uses observations of children to inform her self-evaluation. She uses this information to identify any strengths and weaknesses so that she can develop future targets for the setting.
- The provider meets the requirements of the Early Years Register and the Childcare Register.

Information about this inspection

Inspections of registered early years provision are:

- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate

- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children on roll when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children on roll, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

The inspector sampled the provider's policies and procedures, and discussed how

- these were used when caring for children to meet the safeguarding and welfare requirements.
- The inspector discussed with the provider how the educational programme was delivered for children.
- The inspector undertook a tour of the premises, including the areas the provider used for the provision and the outdoor area.
- The inspector discussed the provider's plans for self-evaluation and improvement plan for the future.

Information about the setting

EM3 Kids Club registered in 2013 and is operated by EM3 Kids Club Limited, a private company. The setting is situated in Dagenham, within the London Borough of Barking and Dagenham. The setting is situated within Harmony House, a community facility that offers community adult services and a nursery during the day. Children attending the club have sole use of the 'Sacred Space' room for the main indoor play activities, the dining room and associated facilities. There is an outdoor play area. The setting provides after-school care, during term-time, Monday to Friday, from 3.15pm to 6.30pm and operates for a period during the school summer holiday. The staff collect children from St Peters Primary R.C. School, Jame Campbell Primary School, Parsoles Primary School and Godwin Primary School. The setting is registered on the Early Years Register, and both parts of the Childcare Register. The setting employs three members of staff, including the manager. Of these, two members of staff hold appropriate early years qualifications to level 3 and one staff member and the provider are currently working towards gaining a recognised qualification. There were no children on roll in the early year's range during the inspection.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages.
