The quality and standards of the early years provision

The provision meets requirements

- The childminder has a sound knowledge and understanding of child protection issues and knows the procedures to follow if she has concerns about a child.
- She is clear about her responsibilities to promote children's health and safety including the procedures for the supervision of children.
- The childminder carries out regular risk assessments indoors and outdoors. The childminder commented that she would not use the garden because it is unsafe for children.
- The inside of the premises are safe, secure and include the necessary facilities for children. There is a suitable range of good quality toys and equipment that are developmentally appropriate for the needs of the children.
- The childminder explains how she would manage children's behaviour according to their age and understanding and use praise to support children's self-esteem.
- The childminder explains how she would use information from her written observations and assessments to plan a range of activities to support children's learning and development.
- The childminder acknowledges the importance of working with parents and other professionals to contribute to the wellbeing of the children.
- The childminder has appropriate addressed the action and recommendation set at the last inspection. Thus demonstrating a capacity to make improvements to her practice.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children on roll when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children on roll, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

The inspector asked the provider questions to assess her understanding of the

- safeguarding and welfare and also how she intends to deliver the educational programmes for children
- The inspector looked at a selection of documents that the provider will use when minding children.
- The inspector observed the suitability and quantity of toys and equipment for when the provider is caring for children

Information about the setting

The childminder was registered in 2002. She lives with her husband and their 14 year old son and two adult children in Wanstead within the London borough of Redbridge. The childminder's kitchen and dinning area is used for childminding.

The childminder is registered on the Early Years Register and both the compulsory and voluntary part of the Childcare Register. There are no children in the early years age group on roll at the time of the inspection. The childminder provides care for children aged over five to 11 years old after school. She drives to local schools to collect the children.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages. It regulates and inspects childcare and children's social care, and inspects the Children and Family Court Advisory Support Service (Cafcass), schools, colleges, initial teacher training, work-based learning and skills training, adult and community learning, and education and training in prisons and other secure establishments. It assesses council children's services, and inspects services for looked after children, safeguarding and child protection.
