## The quality and standards of the early years provision

## The provision meets requirements

- Through discussion the childminder demonstrates she has a clear understanding of the safeguarding and welfare requirements, and how to promote safety and the wellbeing of children. For example, she explains her risk assessment and child protection procedures, and knows what to do if she had any concerns for a child in her care. She is fully aware of notifying Ofsted of any significant events.
- The childminder demonstrates, through discussion, that she will plan and deliver the learning and development requirements. She states she will plan challenging activities that cover all areas of learning and the activities will be based around the interests of each child.
- The childminder demonstrates a sound understanding of working in partnership with parents. For example, she will involve them in their child's learning and will provide written information about their child's progress. She will have regular discussions with them to share information and meet each child's needs.
- The childminder understands the benefit of self-evaluation. She states she will involve parents and children, and talk to them about any improvements they may wish to see. She states she will have questionnaires so that she can continue to improve outcomes for children in her care.

## Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children on roll when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children on roll, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

## **Inspection activities**

- The inspector looked at policies and documents the provider will use when caring for children.
- The inspector and childminder discussed the childminder's self-evaluation form, and improvement plan.
- The inspector held discussions with the childminder about how she intends to deliver the educational programmes for children.

# Information about the setting

The childminder was registered in 2006. She lives in a second floor flat in Hornsey Rise, in the London Borough of Islington. The kitchen, living room and play room are used for childminding. Access to the premises is via a lift and stairs. There is no garden for outdoor play, so the childminder takes children to local parks and groups. The childminder currently has no children on roll. She is registered on the Early years Register, and the compulsory and voluntary parts of the Childcare Register.

### Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.
