#### The quality and standards of the early years provision

#### The provision meets requirements

- The childminder has a sound understanding of how to implement the learning and development requirements of the Early Years Foundation. She has suitable systems to monitor, assess and plan for children's progress.
- The childminder demonstrates a positive attitude towards continuous improvement of her provision to improve outcomes for children.
- The childminder offers a warm and clean home, and has measures in place to promote children's health appropriately. For instance, her first aid certificate is up to date and a first aid kit is available.
- The childminder has a sound awareness of safeguarding children, including the procedures to follow if she was concerned about a child. In addition, she is aware of safety in the home and outdoors, to further protect children.
- The childminder has built positive relationships with parents and other early years providers to help ensure continuity of care for the children.
- The childminder understands the requirements to maintain documentation appropriately, to support the safe management of her provision.

#### Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children on roll when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children on roll, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

#### **Inspection activities**

- The inspector had a tour of the premises, viewed resources and checked all areas available for childminding.
- The inspector discussed the childminder's self-evaluation with her and her knowledge of the Early Years Foundation Stage requirements.
- The inspector sampled written policies and procedures, risk assessments and available records, including those relating to aspects of the welfare requirements.

#### Information about the setting

The childminder registered in 2013 on the Early Years Register and the compulsory and voluntary parts of the Childcare Register. She lives with her husband and three young children. The family live in the Abbey wood area of the London Borough of Greenwich, close to local parks, schools, shops and public transport links. Children have access to the ground floor living room and small playroom. Toilet facilities and one spare bedroom are available on the first floor. There is a garden for outdoor play. The childminder is currently minding four school age children. She currently has no children on roll in the early years age group. The childminder operates all year round, Monday to Friday, except public and family holidays. She is a member of a professional childminding association.

## Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages. It regulates and inspects childcare and children's social care, and inspects the Children and Family Court Advisory Support Service (Cafcass), schools, colleges, initial teacher training, work-based learning and skills training, adult and community learning, and education and training in prisons and other secure establishments. It assesses council children's services, and inspects services for looked after children, safeguarding and child protection.
