#### The quality and standards of the early years provision

#### The provision meets requirements

- Staff understand how children learn and develop. They discuss the wide variety of interesting and fun activities that they provide for all children. They explain how they take account of children's interests and needs in their planning.
- Staff discuss how they place high importance on the safety of the children. They understand the safeguarding policies and procedures and conduct daily checks of the premises to ensure the environment is welcoming, well-resourced and safe for all children.
- Staff discuss how they act as good role models and employ agreed strategies to support children's behaviour. This promotes children's well-being.
- The staff discuss how they work closely with the school's staff in order to offer continuous support and complement children's learning through the club's activities.
- The manager is very organised and keeps all required documentation available for inspection. She evaluates staff practice and is committed to development.

# Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

# **Inspection activities**

- The inspector had a tour of the premises.
- The inspector took account of the views of the parents through discussions and feedback forms.
- The inspector looked at children's learning files and some photographs of their activities.

The inspector sampled required documentation including the after school club's

- policies and procedures and discussed aspects of their safeguarding practice with the staff.
- The inspector discussed the club's self- evaluation systems with the provider.

# **Full report**

#### Information about the setting

Brighter Horizons registered in 2013 and is one of two out of school provisions run by a private provider. The club operates from St Mark's Primary School in Hanwell, in the London Borough of Ealing. The club operates from the main school hall and one smaller room, but also has use of some other rooms when required. There is an enclosed playground for outdoor play. The club operates during school term times from 7.45am to 8.50am and 3.15pm to 6pm, Monday to Friday. The club is open to children of St Mark's School only. The club is registered on the Early Years Register and the compulsory and voluntary parts of the Childcare Register. There are currently 65 children on roll. There were no children present in the early years age range at the time of the inspection. The club employs six qualified staff, including the manager.

# Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages. It regulates and inspects childcare and children's social care, and inspects the Children and Family Court Advisory Support Service (Cafcass), schools, colleges, initial teacher training, work-based learning and skills training, adult and community learning, and education and training in prisons and other secure establishments.
