The quality and standards of the early years provision

The provision does not meet requirements

- The inspection was prioritised by Ofsted following concerns raised about the childminder's ability to safeguard children. The childminder has limited understanding of the safeguarding and welfare requirements. Consequently, she is not meeting a number of legal requirements which also relate to the requirements of the Childcare Register.
- The childminder has failed to ensure that her assistant has a basic first-aid certificate and risk assessments are inadequate in identifying and minimising hazards. Consequently, the childminder cannot demonstrate her understanding of how to continually promote children's welfare and how to keep them suitably protected.
- The childminder demonstrates a suitable knowledge and understanding of the educational programmes and how to promote the learning and development of young children. She describes how she observes and assesses children and uses the information gathered to plan for the next steps in their learning.
- The childminder has a range of good quality resources and play materials and some of these are stored in ways that children can easily access.
- The childminder explained her suitable understanding of how to support children's healthy development by providing nutritious food and daily opportunities for physical exercise.
- The childminder demonstrates a commitment to building links with parents, with whom she shares appropriate information to meet children's care needs.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

Inspection activities

- The inspector toured the areas of the premises where childcare is to be provided. She also looked at the furniture equipment and toys.
- The inspector discussed with the childminder how she intends to deliver the educational programme for children.
- The inspector looked at policies and documents the childminder will use when caring for children and discussed self-evaluation and improvement plans.
- The inspector checked evidence of suitability and training of the childminder and assistant.

Information about the setting

The childminder was registered in 2012 and is on the Early Years Register and the compulsory and voluntary parts of the Childcare Register. She lives with her husband and son in the Swinton area of Salford. The whole of the ground floor is used for childminding. Children also have access to the rear bedroom. There is an enclosed rear play area for outdoor play. The childminder supports children with special educational needs and/or disabilities and children who speak English as an additional language. There were no children present in the early years age range at the time of the inspection. The childminder provides care for older children before and after school and sometimes works with an assistant. The childminder holds a BA honours degree in Childhood Studies and is a member of the Professional Association for Childcare and Early Years.

What the setting needs to do to improve further

To meet the requirements of the Early Years Foundation Stage the provider must:

- ensure at least one person who has a current paediatric first-aid certificate is on the premises at all times when children are present, and must accompany children on outings
- ensure that the outdoor space is secure and fit for purpose, by identifying and dealing with hazards, this particularly relates to the wire fencing surrounding the garden.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.
