#### The quality and standards of the early years provision

#### The provision meets requirements

- The childminder explains how she will assess children's starting points on entry to the setting. She will plan activities around children's interests so that children continue to be motivated to learn.
- The childminder explains how she will support children to learn about leading healthy lifestyles through healthy, balanced and nutritious meals and snacks. She plans to take children outside daily for fresh air and exercise.
- The childminder explains how she will safeguard children and demonstrates how she will do this by following the guidance of the Local Safeguarding Children Board.
- The childminder explains that she will provide information to parents about their child's learning and development so that this can also be followed at home.
- The childminder plans to seek the views about her service from observing children and engaging with parents verbally and using questionnaires. This will help her identify any strengths and weaknesses so that she can develop future targets for her setting.

### Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

## **Inspection activities**

- The inspector sampled the childminder's policies and procedures, and discussed how she would use them when caring for children.
- The inspector discussed with the childminder how she intends to deliver theeducational programmes for children.
- The inspector undertook a tour of the premises, including the areas she plans to use for childminding.
- The inspector discussed the childminder's plans for self-evaluation and her improvement plan for the future.

#### Information about the setting

The childminder registered in March 2010. She lives with her husband and six year old child in a first floor flat in Muswell Hill, in the London Borough of Haringey. The premises are accessed by a flight of stairs, there is no lift service. The childminder uses all areas of the home for childminding. The childminder does not have access to a garden; however, she takes children to local parks on a regular basis. The childminder is registered on the Early Years Register and the voluntary and compulsory parts of the Childcare Register. She currently has no children on roll.

## Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages. It regulates and inspects childcare and children's social care, and inspects the Children and Family Court Advisory Support Service (Cafcass), schools, colleges, initial teacher training, work-based learning and skills training, adult and community learning, and education and training in prisons and other secure establishments. It assesses council children's services, and inspects services for looked after children, safeguarding and child protection.
