The quality and standards of the early years provision

The provision meets requirements

- The childminder has a good knowledge and understanding of the learning and development requirements. She has considered how she will use observation and assessment to plan for children's individual needs and help them to make progress.
- The childminder demonstrates a secure understanding of the safeguarding and welfare requirements, in particular the safeguarding procedures and her role and responsibility in protecting children in her care. Clear behaviour management strategies are in place.
- Resources are plentiful, of good quality and cover the areas of learning. The childminder demonstrates how she will use the resources to help support children's learning through their play.
- Through discussion, the childminder demonstrates a commitment to building partnerships with other early years settings and professionals in order to ensure progression, support and continuity of learning and care.
- There are appropriate measures to ensure that children's health and well-being are promoted. Arrangements for the provision of healthy snacks and meals are clear with regard to individual dietary needs.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

Inspection activities

The inspector had discussions with the childminder about her knowledge and

- understanding of the requirements relating to safeguarding and welfare, and learning and development.
- The inspector looked at the rooms that will be used by minded children.
- The inspector looked at the childminder's documentation, including policies and procedures, and discussed her plans for future improvement.
- The inspector looked at some of the resources that the childminder has in place.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.
