The quality and standards of the early years provision

The provision meets requirements

- The provider has a sound understanding of the importance of using good teaching methods to support the learning and developmental needs of children of all ages. Experienced staff are recruited as play leaders, so that individual support for children can be provided as and when necessary. This means that all children will be able to participate in the activities provided.
- The provider understands how to plan children's activities. These will be based on themes and linked into their interests and needs, to support their learning and development in a fun manner. Art and craft activities will be provided to children along with opportunities for physical play.
- Through discussion and the documents seen, the provider shows that he has an appropriate knowledge of the learning and development requirements. There are positive steps in place to build close relationships with parents, in order to promote continuity in children's care and learning.
- Through discussion and the documents seen, the provider shows that he has a clear understanding of how to safeguard children. Clear systems are in place to ensure safe recruitment procedures are followed, to ensure all those working with children are suitable to do so. Training and induction programmes are in place, so that staff are clear about their roles and responsibilities.
- Detailed risk assessments and daily check lists ensure that any potential hazards are dealt with immediately. This means that children's safety is given priority.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

- The inspector discussed with the registered person how he intends to deliver the educational programmes for children through the varied activities offered.
 - The inspector discussed recruitment procedures and how staff suitability is
- established. She also discussed policies and procedures used by the creche and the holiday play scheme.
- The inspector met staff caring for older children. She discussed how activities are organised and how these would be adapted to meet younger children's needs.
- The inspector observed all areas to be used by children. She also discussed the evaluation process and how this will be used to strive for continuous improvement.

Information about the setting

Bushey Grove Leisure Centre Play Scheme and Creche were registered in 2001. It is on the Early Years Register and the compulsory and voluntary parts of the Childcare Register. It operates from facilities within Bushey Grove Leisure Centre in Bushey, Hertfordshire. It is managed by Hertsmere Leisure. Children using the creche have access to a purpose built room for this purpose. Children using the holiday playscheme have use of various sports halls and a dance studio. Enclosed areas for outdoor play are also available. The holiday playscheme serves children and families from the local and surrounding areas. The holiday playscheme employs suitably qualified staff. Many of these have a recognised qualification at level 3 or a teaching qualification. The creche opens according to demand on Monday to Friday from 9.30am to 12.30pm. The holiday playscheme opens Monday to Friday, from 8.30am to 5pm, during half-term school breaks, Easter and summer holidays. There are currently no children on roll in the early years age range.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages.
