The quality and standards of the early years provision

The provision meets requirements

- The childminder demonstrates she understands how to support children to acquire the skills to learn and develop. She knows how to use observation and assessment to identify the next stages in children's learning, and plans activities designed to help them make progress.
- The childminder demonstrates high expectations of children. She creates an environment designed to motivate, challenge and engage children whilst supporting their interests.
- The childminder has an appropriate understanding of how to protect and support the children in her care. She maintains a clear procedure for ensuring all necessary steps are taken to ensure children are safeguarded and protected from harm.
- The childminder has systems in place to develop partnerships with parents and other providers. This means that she is able to gather and share information to identify children's needs, support their well-being, and help them to make progress.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle – the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

Inspection activities

- The inspector discussed with the childminder how she intends to deliver the educational programmes for children within the early years age range.
- The inspector sampled a range of documentation including policies, procedures and record books.
- The inspector discussed with the childminder how she evaluates the childminding provision and how she intends to make improvements to support children in the future.

Information about the setting

The childminder lives with her husband, one adult daughter and children aged 11, 10 and seven years in a detached house in a village on the outskirts of Goole in East Yorkshire. All of the ground floor of the home is used for childminding purposes, with toilet facilities situated on this level. There is an enclosed garden to the rear of the premises for outdoor play. The home is within walking distance of local amenities, such as a school, shop and a park. The family has a cat, a dog and four chickens. The childminder is registered by Ofsted on the Early Years Register and both the compulsory and voluntary parts of the Childcare Register. She is registered to care for five children under eight years at any one time, of whom three may be in the early years age group. There were no children present at the time of the inspection.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages. It regulates and inspects childcare and children's social care, and inspects the Children and Family Court Advisory Support Service (Cafcass), schools, colleges, initial teacher training, work-based learning and skills training, adult and community learning, and education and training in prisons and other secure establishments.
