The quality and standards of the early years provision

The provision meets requirements

- The childminder demonstrates a good knowledge and understanding of how to promote the learning and development of young children. She uses her observations of children's play to assess their level of progress and identify and plan for their next steps in learning. Journals are used to record and monitor their progress so the childminder can tailor the support for children as required.
- The childminder has a written policy on behaviour management. She is able to demonstrate, through discussion, how to implement positive behaviour management strategies to support children's emotional development.
- The childminder offers a welcoming environment and explains how she ensures children are well supervised and are not left with persons who have not been vetted. She understands the requirements to inform Ofsted of any changes.
- The childminder has a wide range of good quality toys and resources, which are stored at low level to help support children's independence and decision-making skills.
- The childminder is aware of her responsibilities to safeguard children and how to implement her policy for child protection. Written risk assessments and daily checks help to identify potential hazards to ensure children's safety in the home. Effective procedures for outings further support children's safety in the community.
- Through discussion, the childminder demonstrates a commitment to building links with parents, with whom she shares appropriate information. In addition, she attends local groups and liaises with the local authority to meet the needs of children and their families.
- A comprehensive selection of policies, procedures and children's records are well maintained and regularly reviewed to ensure they are pertinent to her practice.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle – the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

Inspection activities

- The inspector discussed with the childminder how she intends to deliver the educational programmes for children.
- The inspector looked at policies and documents the childminder will use when caring for children.
- The inspector checked evidence of suitability of the childminder and all adults living in the house.

Information about the setting

The childminder was registered in 2010 and is on the Early Years Register and the compulsory and voluntary parts of the Childcare Register. She lives with her husband, on adult child and two children aged 11 and eight years in Rochdale. The whole of the ground floor, the bathroom on the first floor and the rear garden are used for childminding. The childminder attends a toddler group and activities at the local children's centre. She visits the shops and park on a regular basis and collects children from the local schools and pre-schools. The childminder operates all year round from 7am to 6pm, Monday to Friday, except Bank Holidays and family holidays. At the time of the inspection there were no children on roll in the early years age group.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages. It regulates and inspects childcare and children's social care, and inspects the Children and Family Court Advisory Support Service (Cafcass), schools, colleges, initial teacher training, work-based learning and skills training, adult and community learning, and education and training in prisons and other secure establishments.
