#### The quality and standards of the early years provision

#### The provision meets requirements

- The childminder demonstrates a sound understanding of the learning and development requirements of the Early Years Foundation Stage. She understands how to plan appropriate activities to meet children's individual learning needs and how to assess their ongoing development.
- The environment is safe and secure. The childminder understands how to promote children's safety and welfare. She has attended extensive training in child protection, which gives her secure knowledge and understanding of how to safeguard children from abuse.
- The childminder understands how to promote children's health and well-being as well as how to positively manage children's behaviour. For example, she describes how she will promote regular exercise and offer lots of opportunities for outdoor play. She also explains how she will encourage positive relationships and help children to value diversity.
- The childminder understands the need to work in partnership with parents and other professionals to meet children's care and learning needs and to support their transitions. She has developed a useful booklet to share with parents. This includes information about the Early Years Foundation Stage, with examples of activities and resources to promote seven areas of learning.
- The childminder demonstrates a commitment to ongoing professional development and training. She regularly attends local authority quality network meetings, which helps her to keep up-to-date with practice issues and changes.
- The childminder holds a current paediatric first-aid certificate and she is also qualified as a childcare assessor.

## Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

## **Inspection activities**

■ The inspector observed areas to be used for childminding.

The inspector discussed with the childminder how she intends to deliver the

- educational programmes for children and undertake observation, assessment and planning.
- The inspector checked evidence of suitability of household members and looked at the childminder's training certificates.
- The inspector sampled a range of policies and documents the childminder will use when caring for children and discussed self-evaluation.

#### Information about the setting

The childminder was registered in 2010 and is on the Early Years Register and the compulsory and voluntary parts of the Childcare Register. She lives with her mother in a house in Burnage, Manchester. The whole of the ground floor and the rear garden are used for childminding. The childminder speaks a number of languages, including English, Urdu, Punjabi and Hindi. She operates all year round from 7am to 6pm, Monday to Friday, except bank holidays and family holidays. The childminder holds an appropriate early years qualification at level 3. At the time of the inspection, there were no children on roll.

## Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages. It regulates and inspects childcare and children's social care, and inspects the Children and Family Court Advisory Support Service (Cafcass), schools, colleges, initial teacher training, work-based learning and skills training, adult and community learning, and education and training in prisons and other secure establishments.
