# The quality and standards of the early years provision

# The provision meets requirements

- The childminder has a suitable knowledge and understanding of how children learn and develop through play. She has an appropriate range of toys and resources to support children's all-round development.
- The childminder has a commitment to work in partnership with parents to ensure continuity of care and learning for children. This supports their emotional well-being.
- The childminder understands the importance of encouraging children to be independent throughout their play and daily routines in order to develop their self-care skills.
- The childminder understands how to support children's health and well-being. She discusses the importance of providing children with a healthy diet and has a clear awareness of how to manage children's behaviour.
- The childminder has a sound knowledge and understanding of the safeguarding and welfare requirements. This is further supported by a good range of written policies and procedures to ensure that children are cared for within a safe and secure environment.
- The childminder has addressed the actions and recommendations from the last inspection. For example, she has developed her observation systems and updated her risk assessment records. This demonstrates a capacity to maintain continuous improvement.
- The childminder holds public liability insurance and a current paediatric first-aid certificate.

# Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

# Information about the setting

The childminder was registered in 1981 and is on the Early Years Register and the compulsory and voluntary parts of the Childcare Register. She lives with her husband in Droylsden, Manchester. The whole of the ground floor and rear garden are used for childminding purposes. The childminder attends activities within the local area. She collects children from the local schools and pre-schools. There are currently no children on roll in the early years age group. The childminder operates all year round from 8am until 6pm, Monday to Friday, except for family holidays.

# Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.
