The quality and standards of the early years provision

The provision meets requirements

- The childminder demonstrates a suitable understanding of the educational programmes and how to provide stimulating activities for children. She knows how to assess and monitor children's progress.
- The childminder understands her strengths and what she needs to develop. This shows that she reassesses her provision to ensure that young children's individual care and learning needs are met.
- The childminder is approachable and friendly. She demonstrates a good understanding of the importance of working in partnership with parents. She understands her role in exchanging information with them on a regular basis to provide continuity in children's learning.
- The childminder has a sound knowledge of child protection procedures and understands her responsibility to protect the welfare of the children in her care.
- The childminder demonstrates how she promotes a healthy lifestyle for children. She encourages a healthy diet and provides children with plenty of fresh air and exercise. They play in her garden, go on visits to the park and take part in planned physical games, such as sports days.
- The childminder's documentation is very well organised. She has a good range of policies, procedures and risk assessments, which she shares with parents.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

Inspection activities

- The inspector checked evidence of suitability of the childminder and household member.
- The inspector observed areas to be used for the care of children, and discussed how she will acquire suitable and accessible toys that are to be used for childminding.
- The inspector discussed with the childminder their plans for self-evaluation and improvement.

- educational programmes for children and undertake observation, assessment and planning.
- The inspector looked at the childminder's training certificates, policies and documents that will be used when caring for children.

Information about the setting

The childminder was registered in 2010 and is on the Early Years Register and the compulsory and voluntary parts of the Childcare Register. She lives with her husband and children aged 12, nine and seven in a house in the Blackley area of Manchester. The whole of the ground floor, a bedroom and bathroom on the first floor and the front and rear gardens are used for childminding. The premises is accessible by a few stone steps. The family has a pet hamster. At the time of the inspection there were no early years children on roll. There are currently two older children on roll who attend on various days and sessions. The childminding provision operates all year round, from 7am to 6pm Monday to Friday, except bank holidays and family holidays. The childminder is a member of the Professional Association for Childcare and Early Years.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.
