The quality and standards of the early years provision

The provision meets requirements

- The childminder has a good knowledge and understanding of the learning and development requirements. She explains how she will identify children's starting points and use assessment to monitor their progress.
- The childminder demonstrates a good understanding of how to support new children to settle into her home. She makes sure that she finds out important information from parents during their settling-in visits in order to acknowledge children's emotional needs.
- The childminder has a sound understanding of how to promote a healthy lifestyle when caring for children. She is aware of providing balanced meals and planning regular outdoor play, knowing that children benefit from getting plenty of fresh air and exercise.
- The childminder demonstrates her secure knowledge of how to safeguard children's welfare and what to do should she have any concerns about children in her care. In addition, she effectively identifies and minimises risks in her home to keep children safe.
- The childminder explains how she will work in partnership with parents and other early years providers. Furthermore, she considers how to support children's individual needs, regularly sharing information with others to maintain continuity of care and learning.
- The childminder has a positive attitude towards driving improvement through evaluating her provision. She identifies areas for improvement that will have a positive impact on children's learning.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

Inspection activities

- The inspector had a tour of the childminder's home.
- The inspector held discussions with the childminder regarding how she intends to deliver the educational programmes for children.
- The inspector looked at policies and documents the childminder will use when caring for children.
- The inspector discussed self-evaluation and plans for improvement with the childminder.
- The inspector sampled relevant documentation, including policies, procedures and evidence of the suitability of the childminder and other adults in the household.

Information about the setting

The childminder was registered in 2001 and is on the Early Years Register and the compulsory and voluntary parts of the Childcare Register. She lives in Coventry with her partner and two children aged 14 and nine years. The whole ground floor of the house and the rear garden are used for childminding. The family has two pet dogs. The childminder visits shops and the park on a regular basis. She takes children to and from the local schools and pre-schools. The childminder operates all year round Monday to Friday, except for Bank Holidays and family holidays. During term time, she operates from 7am to 9am and 3.15pm to 5.30pm, although these times are negotiable. During school holidays, she operates from 7am to 5.30pm. The childminder has an early years qualification at level 3 and is a member of the Professional Association for Childcare and Early Years. At the time of the inspection there were no children on roll in the early years age group.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages. It regulates and inspects childcare and children's social care, and inspects the Children and Family Court Advisory Support Service (Cafcass), schools, colleges, initial teacher training, work-based learning and skills training, adult and community learning, and education and training in prisons and other secure establishments.
