The quality and standards of the early years provision

The provision meets requirements

- The childminder has a good understanding of child protection procedures. She has recently updated her safeguarding knowledge through training. Therefore, she clearly understands how to protect the welfare and safety of children.
- The childminder demonstrates a good understanding of the importance of working in partnership with parents. She knows that exchanging information with them on a regular basis provides consistency and continuity in children's learning.
- The childminder is proactive in keeping herself up to date with changes in childcare legislation, through reading and accessing relevant websites.
- The childminder has a good knowledge and understanding of the learning and development requirements of the Early Years Foundation Stage. She knows how to provide appropriate activities and play opportunities that cover the seven areas of learning and help children make progress.
- The childminder understands how to promote a healthy lifestyle for children. She understands the importance of a healthy diet and plenty of fresh air and exercise.
- The childminder has a very good range of equipment, toys and books, which are easily accessible to help promote children's free choice and independence.
- The childminder is friendly and approachable. She provides a comfortable, inclusive environment, which is welcoming to all.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the compulsory part of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

Inspection activities

- The inspector looked at the childminder's training certificates, policies and documents that will be used when caring for children.
- The inspector discussed with the childminder her plans for self-evaluation and improvement.
- The inspector had a tour of the premises and viewed toys, resources and equipment that are to be used for childminding.
- The inspector discussed with the childminder how she intends to deliver the educational programmes for children and undertake observation, assessment and

- The inspector checked evidence of the suitability of the childminder and household members.

Information about the setting

The childminder was registered in 2012 on the Early Years Register and the compulsory part of the Childcare Register. She lives with her husband, two adult children and a child aged five years in a house in Fallowfield, Manchester. The whole of the ground floor, a bathroom on the first floor and the rear garden are used for childminding. At the time of the inspection, there were no early years children on roll. The childminding provision operates all year round, from 7.30am to 6pm Monday to Friday, except bank holidays and family holidays. The childminder is a member of the Professional Association for Childcare and Early Years.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.
