The quality and standards of the early years provision

The provision meets requirements

- The childminder has a good understanding of the learning and development requirements. She clearly explains how she uses observation and assessment to plan activities that meet children's individual learning needs.
- The childminder understands the safeguarding and welfare requirements and has a range of detailed policies to underpin her practice in supporting children's well-being. She regularly risk assesses her home, enabling her to maintain a safe environment for children.
- The childminder has a positive attitude towards inclusion and understands the importance of working in partnership with parents and others to meet children's needs. She provides children with equal access to a good variety of resources to support their learning.
- The childminder has clear evaluation systems and demonstrates a drive to continually improve. She is proactive in attending training to refresh and further develop her knowledge of early years practice.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

Inspection activities

- The inspector observed how the childminder maintains a safe environment for children.
- The inspector discussed with the childminder how she meets the learning and development requirements when caring for children.
- The inspector looked at the childminder's documentation, including the policies she has regard to when childminding.
- The inspector discussed evaluation and improvement with the childminder.

Information about the setting

The childminder registered in 2002. She lives with her three adult children in a residential area of Woking, Surrey. Childminding takes place on the ground floor only, and children have access to a lounge, dining room, kitchen/diner, cloakroom and playroom. There is a garden for outdoor play. The family has three cats. The childminder is registered on the Early Years Register and on the compulsory and voluntary parts of the Childcare Register. She works Monday to Friday for most of the year. The childminder walks or drives to local schools, parks and a gym group for children. At the time of inspection the childminder had no children on roll.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.
