The quality and standards of the early years provision

The provision meets requirements

- The provider has a good understanding about how they can complement children's learning and development at the setting. The staff intend to talk to children, parents and teachers to gain information about children's current hobbies and interests. The staff know how to plan activities, incorporating these interests to help engage children and support their progress.
- The staff know how to plan a range of activities to promote children's learning in all areas of the curriculum. For example, activities are available to encourage children's physical development and increase their ability to assess and manage risk independently.
- The staff appreciate that children need support as they move between school, the setting and home. Consequently, they have procedures to help children to settle and paperwork in place to find out about children's individual needs.
- The provider has a variety of methods available for engaging and involving parents in children's care. For example, parents can find out information through the setting webpage and share their views via questionnaires. The provider uses these views to help evaluate and plan for the future of the setting.
- The provider has a good understanding of how to keep children safe in the setting. There are robust policies and procedures in place, which underpin the work of staff. Furthermore, staff undertake an indepth induction and have regular training. This helps to make sure that their knowledge and understanding of child protection issues are up to date.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle – the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

Information about the setting

Kids Play Camp MK was registered in 2010 and is on the Early Years Register and both the compulsory and voluntary parts of the Childcare Register. It is operated by Kids Play Limited. Kids Play Camp MK runs from Vandyke Upper School and Community College in Leighton Buzzard, Bedfordshire. They have use of a large base room, playground, playing field, an outdoor cafe area and indoor dining area. The setting opens from 8.30am to 6pm, Monday to Friday during the summer and Easter school holidays. Depending on demand, it may operate during other school holidays, such as half terms. The setting is managed on a daily basis by a manager who has a recognised childcare qualification at level 3, under the supervision of the Childcare Director who is a qualified Early Years Teacher. All other staff have a recognised childcare qualification at level 2 or above. There were no children on roll at the time of inspection.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages. It regulates and inspects childcare and children's social care, and inspects the Children and Family Court Advisory Support Service (Cafcass), schools, colleges, initial teacher training, work-based learning and skills training, adult and community learning, and education and training in prisons and other secure establishments.
