Monitoring for provision judged as inadequate

An Ofsted inspector, Rebecca Khabbazi, monitored your provision on 03/09/2014 following your inspection where the provision was judged to be inadequate.

Outcome of monitoring

As a result of our inspection on 07/07/2014, we sent you a notice to improve. If you were set actions at the inspection, or as a result of our subsequent monitoring or investigations, these are included at the end of this letter.

During the monitoring visit the inspector discussed with you the steps you have taken to address the actions raised in the notice to improve. She spoke to you and looked at documentation including recruitment procedures, Disclosure and Barring Service checks and the records you keep for observation, assessment and planning of activities. The local authority advisor has visited the nursery a number of times since the last inspection and the records the advisor gave you with suggestions for improvements were seen.

You have developed a clear action plan to address the issues raised at the last inspection. This has been successful in helping you move forward. You have had the support of the local authority and you value the advice they have given to help you improve your practice.

You have revised your recruitment systems to ensure that they are more robust and you have written a new recruitment and vetting policy. You have implemented this policy for all existing staff as well as new employees. You have now requested references and applied for new Disclosure and Barring Service checks for all staff. This ensures that you make appropriate checks to ensure the ongoing suitability of staff to work with children, which helps safeguard children's welfare. You advise that while staff are waiting for checks to be completed they do not work with children unsupervised.





With the support of the local authority advisor, you have started to make a number of improvements to the educational programme, particularly for children aged under two years. Staff now use the observation and planning system for the younger children that was already in place in the pre-school room. Consequently, younger children now have their own learning and development file. Staff have started to make regular observations of children's achievements and use these to plan activities. In addition, you have ensured that a system is in place to complete progress checks for children aged two years. You advise that staff will shortly begin writing progress reports for children as appropriate. These systems are in their early stages but you demonstrate improving confidence about how you use these to ensure children are appropriately challenged.

Having considered all the evidence, the inspector is of the opinion that the setting has taken prompt and effective action to address the points for improvement.

Next steps

The next step will be a full inspection.
