The quality and standards of the early years provision

The provision meets requirements

- The childminder has a good knowledge of how to provide a range of activities and experiences to help children make good progress.
- The childminder demonstrates a good understanding of the procedures to follow if she has concerns about the welfare of a child. She is confident in her ability to identify the signs and symptoms that may indicate that a child is at risk of harm.
- The childminder understands the documentation requirements of the Early Years Foundation Stage. She understands the importance of maintaining records which includes a complaints procedure and notifying Ofsted of any significant events.
- The childminder understands the importance of working in partnership with parents and other childcare professionals to provide continuity in children's learning.
- The childminder demonstrates a good understanding of the need to evaluate her practice reflectively to make continuous improvements that will benefit children.

- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

Inspection activities

- The inspector discussed with the childminder how she delivers the learning and development requirements of the Early Years Foundation Stage.
- The inspector observed the areas of the home used for childminding and discussed available resources.
 - The inspector sampled a range of documentation which included safeguarding
- procedures, such as child protection, risk assessments, behaviour management and complaints procedures.
- The inspector discussed the self-evaluation process and plans for improvement with the childminder.

The childminder registered in 1992. She lives with her husband in Bredhurst, Gillingham, Kent. The whole of the ground floor of the childminder's house is used for childminding including toilet facilities. The childminder uses local parks as she does not use the garden.

The childminder is registered on the Early Years Register and the compulsory and voluntary parts of the Childcare Register. There were no children on roll in the early years age group at the time of the inspection. The childminder is qualified to level 3 in childcare. The childminder walks to local schools to take and collect children.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.
