The quality and standards of the early years provision

The provision meets requirements

- The childminder demonstrates a satisfactory awareness of the learning and development requirements. She has a suitable understanding of how to observe children's learning and assess what they need to do next in order to progress.
- The childminder appropriately demonstrates how she reduces hazards to children and protects them. For example, she completes written risk assessments for her home and outings.
- The childminder's home is clean and suitably resourced with a range of toys and equipment to meet the needs of the different age groups of children.
- The childminder holds public liability insurance and a current paediatric first-aid certificate.
- The childminder understands how to promote children's well-being. She describes how good relationships are developed through flexible settling-in arrangements, which meet the needs of children and their families. She obtains key information, such as children's specific medical needs and allergies, to provide continuity in the care they receive.
- The childminder understands her role and responsibility in safeguarding children. This is further supported by written policies and procedures and her knowledge of what action to take should she have any concerns about a child in her care.
- The childminder demonstrates a sound understanding of the importance of working in partnership with parents and other providers of the Early Years Foundation Stage. She understands her role in exchanging information with them on a regular basis to provide continuity in children's care and learning.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

Inspection activities

- The inspector looked at the areas of the childminder's home used for childcare along with furniture, equipment and toys that are to be used for childminding.
- The inspector discussed with the childminder how she intends to deliver the educational programmes for children.
- The inspector looked at policies and documents the provider will use when caring for children and discussed self-evaluation and improvement plans.
- The inspector verified evidence of suitability checks of the childminder and adults living on the premises.

Information about the setting

The childminder was registered in 1986 on the Early Years Register and the compulsory and voluntary parts of the Childcare Register. She lives with her husband and adult child in Acklam, Middlesbrough. The whole of the ground floor is used for childminding. There is a rear garden for outside play. She visits the shops and park on a regular basis. She is able to collect children from the local schools and pre-schools. The childminder operates all year round from 8am to 5.30pm, Monday to Friday, except bank holidays and family holidays. She is a member of the Professional Association for Childcare and Early Years. There were no children on roll in the early years age range at the time of the inspection.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages. It regulates and inspects childcare and children's social care, and inspects the Children and Family Court Advisory Support Service (Cafcass), schools, colleges, initial teacher training, work-based learning and skills training, adult and community learning, and education and training in prisons and other secure establishments.
