The quality and standards of the early years provision

The provision meets requirements

- The childminder has a good knowledge and understanding of safeguarding policies and practice to ensure children's safety is paramount. She risk assesses children's play areas well and has a good knowledge of child protection procedures.
- The childminder gives careful consideration to the organisation of space. Children's play area is bright, welcoming and toys and resources are readily available.
- The childminder demonstrates her good knowledge of the learning and development requirements. She shows how she provides exciting activities such as trips to farms and adapts cooking activities to meet the different age range of children.
- The childminder discusses the importance of promoting children's good health through diet, physical activity and good hygiene practice. She holds a current first aid certificate and good knowledge of how to treat children in the event of an accident.
- The childminder has procedures, through effective observation and assessments of children's learning, to provide them with extra support through working effectively with parents and other professionals.
- The childminder demonstrates her commitment and clear capacity for improving her provision. She has completed a range of training to support practice. She shows good organisation of her records and documentation and ensures that her public liability insurance is up to date.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle – the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

Inspection activities

- The inspector held discussions with the childminder about her knowledge of the requirements of the Early Years Foundation Stage.
- The inspector observed the areas where children play and rest.
- The inspector checked documentation that relate to children's health and safety.
- The inspector checked details with regard to the childminder's suitability and knowledge of safeguarding children.

The childminder registered in 2013. She is registered on the Early Years Register and the compulsory and voluntary parts of the Childcare Register. She lives with her school-aged daughter in a first floor flat in Brixton Hill, in the London Borough of Lambeth. There is one flight of stairs to the childminder's home and there is parking facilities nearby. The childminder offers care for children at the weekends and afterschool. At the time of the inspection there were no children no roll.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages. It regulates and inspects childcare and children's social care, and inspects the Children and Family Court Advisory Support Service (Cafcass), schools, colleges, initial teacher training, work-based learning and skills training, adult and community learning, and education and training in prisons and other secure establishments.
