There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

#### Information about the setting

Brambles Playsafe Club is a privately managed out of school provision owned by Jancett Childcare and JACE Training Ltd, that runs 20 nurseries and out of school clubs. It registered in 2012 and re-registered in 2014 due to a change of status. The club runs from Bandon Hill School, in Wallington, Surrey. It provides places for children who attend Bandon Hill School only. Children have access to two play areas located in a separate building to the main school, an undercover outdoor play area, playground sports court, and climbing equipment. Toilets are located within the main school. The provision is registered on the Early Years Register and both the compulsory and voluntary parts of the Childcare Register. There were no children in the early years on roll at the time of the inspection. The club is open from 7.30am to 9am and 3.10pm to 6.30pm, term-time only. A team of four staff are currently employed including the manager, two of whom hold appropriate Early Years Qualifications.

#### Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages.
