The quality and standards of the early years provision

The provision meets requirements

- The childminder understand her responsibilities in safeguarding children. She has a sufficient awareness of the procedures for reporting child protection concerns and potential signs of abuse and neglect. This contributes to protecting the welfare of children.
- The childminder appropriately demonstrates how she keeps children safe, this includes completing risk assessments for her home and outings. She has devised all relevant policies, procedures and documentation relating to safeguarding children.
- The childminder holds public liability insurance and a current first aid certificate.
- The childminder has a sound knowledge and understanding of the learning and development requirements of the Early Years Foundation Stage. She demonstrates a sufficient understanding of using observation and assessment so that she plans and provides challenging activities to meet children's individual learning needs.
- The childminder organises a varied selection of resources around her home, across all areas of learning to support children in making their own choices in play.
- The childminder understands how to promote children's health and well-being. She demonstrates how she uses her garden, outings and outdoor activities to support children in leading a healthy lifestyle. For example, providing opportunities for children to play in the fresh air and to be active.
- The childminder demonstrates she understands the range of information she needs to gather from parents to ensure she meets children's individual needs and care arrangements.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

- The inspector and childminder toured the areas of the home where childcare is to be provided.
- The inspector and the childminder discussed and looked at toys, books, resources and equipment that she intends to use.
- The inspector discussed with the childminder how she intends to deliver the educational programmes for children.
- The inspector looked at policies and documents the childminder will use when caring for children and discussed self-evaluation and improvement plans.
- The inspector checked evidence of the suitability and training of the childminder and suitability of other household members.

Information about the setting

The childminder was registered in 2014 and is on the Early Years Register and the compulsory and voluntary parts of the Childcare Register. She lives with her husband and two children aged 19 years and 12 years in Elsecar, Barnsley. The whole of the ground floor and first floor bathroom are used for childminding. There is a garden available for outdoor play. The childminder has a dog as a pet. The childminder attends a toddler group and activities at the local children's centre. She visits the shops, park and other places of interest with children on a regular basis. She takes and collects children from the local schools, nursery and pre-schools. There are currently no children on roll. The childminding provision operates all year round from 6.30am to 6.30pm, Monday to Friday, except for family holidays. Children attend for a variety of sessions. The childminder is a member of the Professional Association for Childcare and Early Years.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.
