The quality and standards of the early years provision

The provision meets requirements

- Staff clearly understand their responsibility to safeguard children and are very knowledgeable about the possible signs and symptoms of abuse and neglect. They are fully conversant with the procedures to follow, should they have a concern, so that they protect children from harm.
- Staff demonstrate a secure knowledge of how children learn. Through discussion, they show how planning will take account the interests and preferences for each child so that activities are sufficiently focused to meet their individual needs.
- Staff show through discussion, how they will work closely with all parents and other settings that children attend so that they can build on, knowledge, understanding and skills in order to promote continuity of care and learning.
- Staff have a clear understanding of how they will implement carefully planned routines, so that each child's safety and well-being is effectively and consistently promoted.
- The manager has effective systems in place to evaluate and reflect on their practice so that they can analyse their strengths and areas for further improvements.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle – the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

Inspection activities

- The inspector had a tour of the premises with the manager where child care is provided.
- The inspector discussed with the manager and staff how the individual needs of each child will be met to support them to learn effectively.
- The inspector discussed the provider's self-evaluation form and improvement plan.
- The inspector looked at various documents, including policies and procedures, staff training and evidence of the suitability of staff.

Information about the setting

Willows Playsafe Club registered in 2011 and re-registered in 2014 due to a change of legal status. It is located within Woodmansterne Primary School in Surrey. The club is owned and managed by Jancett Childcare and JACE Training Ltd and is open to children from Woodmansterne School. It operates an after school club from 3pm to 6.30pm, for children aged from three years until 11 years of age. The club has sole use of a series of rooms in a separate area of the school, complete with its own toilets and kitchen area. The club has access to the school outdoor areas. Willows Playsafe Club is registered on the Early Years Register and both the compulsory and voluntary parts of the Childcare Register. The club supports children who speak English as an additional language. Three members of staff work at the setting, two of whom are qualified. There were no children in the early years age range on roll at the time of this inspection.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages. It regulates and inspects childcare and children's social care, and inspects the Children and Family Court Advisory Support Service (Cafcass), schools, colleges, initial teacher training, work-based learning and skills training, adult and community learning, and education and training in prisons and other secure establishments.
