The quality and standards of the early years provision

The provision meets requirements

- The childminder has a sound knowledge of the learning and development requirements. She understands how to use observations and assessments to plan challenging activities that help children make progress. She has a broad range of resources to interest children and support their learning.
- The childminder has completed safeguarding training. She shows she is secure in her awareness of what to do if she has any concerns about children in her care. The areas of the home used for children are safe and suitable. The childminder demonstrates how she takes appropriate steps to minimise hazards and supervise children to help them stay safe.
- The childminder has all the required documentation in place to help promote children's welfare. She has sound systems for the two-way exchange of relevant information with parents to ensure continuity in children's care and learning.
- The childminder has been seeking advice from the local authority and is reflecting on, and developing, her practices. This demonstrates that she has the capacity to continue to make improvements to her childcare setting.

Information about this inspection

Inspections of registered early years provision are:

- scheduled at least once in every inspection cycle the current cycle ends on 31 July 2016
- scheduled more frequently where Ofsted identifies a need to do so, for example where provision was previously judged inadequate
- brought forward in the inspection cycle where Ofsted has received information that suggests the provision may not be meeting the legal requirements of the Early Years Foundation Stage or where assessment of the provision identifies a need for early inspection
- prioritised where we have received information that the provision is not meeting the requirements of the Early Years Foundation Stage and which suggests children may not be safe
- scheduled at the completion of an investigation into failure to comply with the requirements of the Early Years Foundation Stage.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The provision is also registered on the voluntary and compulsory parts of the Childcare Register. This report includes a judgment about compliance with the requirements of that register.

Inspection activities

- The inspector discussed with the childminder how she will deliver the educational programmes to children.
- The inspector sampled the childminder's policies and documentation she uses when caring for children.
- The inspector looked around the areas of the home and garden used for children and discussed safety with her.
- The inspector discussed with the childminder her self-evaluation form and development plan.

The childminder registered in 2009. She has a recognised childcare qualification at level 3. She lives with her two children in a house in Edenbridge, Kent near to schools, shops and parks. The whole of the ground floor of the property is used for childminding. There is a garden available for supervised outside play. There are steps in the outdoor area. The childminder is registered on the Early Years Register, and the compulsory and voluntary parts of the Childcare Register. There are no children in the early years age range currently on roll.

Type of provision

For the purposes of this inspection the following definitions apply:

Full-time provision is that which operates for more than three hours. These are usually known as nurseries, nursery schools and pre-schools and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the higher fee for registration.

Sessional provision operates for more than two hours but does not exceed three hours in any one day. These are usually known as pre-schools, kindergartens or nursery schools

and must deliver the Early Years Foundation Stage. They are registered on the Early Years Register and pay the lower fee for registration.

Childminders care for one or more children where individual children attend for a period of more than two hours in any one day. They operate from domestic premises, which are usually the childminder's own home. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage.

Out of school provision may be sessional or full-time provision and is delivered before or after school and/or in the summer holidays. They are registered on the Early Years Register and must deliver the Early Years Foundation Stage. Where children receive their Early Years Foundation Stage in school these providers do not have to deliver the learning and development requirements in full but should complement the experiences children receive in school.

The Office for Standards in Education, Children's Services and Skills (Ofsted) regulates and inspects to achieve excellence in the care of children and young people, and in education and skills for learners of all ages. It regulates and inspects childcare and children's social care, and inspects the Children and Family Court Advisory Support Service (Cafcass), schools, colleges, initial teacher training, work-based learning and skills training, adult and community learning, and education and training in prisons and other secure establishments.
